
DESCRIPTION/DETAILS

An early cape style house with a smaller wing, this house likely dates to about 1800. Town assessor's record indicates built 1750, however, hardware and other architectural details indicate a later date. Further research is needed to possibly determine age of the house.

This house/property was purchased by Adolf Kindler in 1918 (v34 pg 592) from Minna Goodwin. It was eventually sold to his son Alvin, then Alvin sold to his son and daughter in law Alvin and Dorothy Kindler. After Alvi's death, Dorothy retained ownership until 2001 when she sold the property to her daughter and son in law Darlene and Gregory Finamore. The Finamore's sold to Sanat Patel in April 2023. It is under the Patel ownership that the house, barn and smoke house were torn down and cleared away.

In 2017, THS realized that the buildings were in an accelerated state of decay, had been vandalized extensively and the demise of the buildings was not far into the future. Permission was obtained from the owners and many photos were taken, now stored in the THS digital collection. At that time, the house still had many family belongings in it that had been strewn about by vandals.

This house is shown in both the 1856 and 1869 early maps of Thompson. Ownership noted is "S. Town" and "Sherman Town". There are other of the Town name listed nearby, all believed to be family. The name spelling of "Town" on the maps is incorrect as other early records indicating "Towne" as the proper spelling.



Ellen Larned, in her "First Families" articles, wrote about Joseph Towne who had settled in Thompson in 1733. She mentions that the location of his original property was unknown, however believes that descendants lived upon portions of the land Joseph owned. She mentions Sherman Towne as great grandson of Joseph Towne of 1733 settlement and that the house was believed to have been owned by Sherman's father Joseph III. Ellen noted "the remarkable stone walls bounding his lands will long stand in witness of his persevering industry". These walls she mentioned are very impressive in size, measuring

5 feet wide or more and built by laying two rows of walls parallel and filling in the center. The walls were likely built in this manner due to the very large volume of stone that covers the ground all around the house. Unfortunately, as of this writing (5/2024), sections of the walls, on the east side of Pasay Road and south of the house, have been torn apart by excavators.

Not visible in the above images was a small building, approximately $4' \times 6'$ long and about 4 feet tall. It had a gable roof with a doorway on one end. The construction was early and possibly dated to the mid 19^{th} century. It was made of brick with a wood roof and sat on cut granite stone for a foundation. The floor was of dirt possibly layered over the granite. While unsure of its purpose, it is possible that it was used as a smoke house.

The stone walls of the property, as mentioned above, were very wide making them very visible in the 1934 aerial photos.




In both aerial photos, the house can be seen north of the barn. Both buildings are on the east side of Pasay Road. Visible in 1934 is a third building that was on the west side of Pasay Road across from the barn. This appears to be gone in 1965. Also seen in 1934 is a fourth building directly east of the house.




Below is a 2016 view via satellite and Lidar. The driveway is visible in the Lidar image. Also note in the lidar image the width of the stone walls and the proportion as compared to the width of Pasay Road.



This Lidar view shows the approximate bounds of the Patel purchase. The purpose of this view is to record the original stone wall layout before any possible future changes might take place. The ovals indicate location of house and barn.


